

In the Senate of the United States,

March 17, 2016.

Resolved, That the bill from the House of Representatives (H.R. 4721) entitled “An Act to amend title 49, United States Code, to extend authorizations for the airport improvement program, to amend the Internal Revenue Code of 1986 to extend the funding and expenditure authority of the Airport and Airway Trust Fund, and for other purposes.”, do pass with the following

AMENDMENT:

Strike all after the enacting clause and insert the following:

1 ***SECTION 1. SHORT TITLE; TABLE OF CONTENTS.***

2 (a) *SHORT TITLE.*—*This Act may be cited as the “Air-*
3 *port and Airway Extension Act of 2016”.*

3 *SEC. 101. EXTENSION OF AIRPORT IMPROVEMENT PRO-* **4 *GRAM.***

5 *(a) AUTHORIZATION OF APPROPRIATIONS.—*

6 *(1) IN GENERAL.—**Section 48103(a) of title 49,*
7 *United States Code, is amended by striking*
8 *“\$1,675,000,000 for the period beginning on October*
9 *1, 2015, and ending on March 31, 2016” and insert-*
10 *ing “\$2,652,083,333 for the period beginning on Octo-*
11 *ber 1, 2015, and ending on July 15, 2016.”.*

12 *(2) OBLIGATION OF AMOUNTS.—**Subject to limi-*
13 *tations specified in advance in appropriation Acts,*
14 *sums made available pursuant to the amendment*
15 *made by paragraph (1) may be obligated at any time*
16 *through September 30, 2016, and shall remain avail-*
17 *able until expended.*

18 *(3) PROGRAM IMPLEMENTATION.—**For purposes*
19 *of calculating funding apportionments and meeting*
20 *other requirements under sections 47114, 47115,*
21 *47116, and 47117 of title 49, United States Code, for*

1 *the period beginning on October 1, 2015, and ending*
 2 *on July 15, 2016, the Administrator of the Federal*
 3 *Aviation Administration shall—*

4 *(A) first calculate such funding apportion-*
 5 *ments on an annualized basis as if the total*
 6 *amount available under section 48103 of such*
 7 *title for fiscal year 2016 were \$3,350,000,000;*
 8 *and*

9 *(B) then reduce by 20.83 percent—*

10 *(i) all funding apportionments cal-*
 11 *culated under subparagraph (A); and*

12 *(ii) amounts available pursuant to sec-*
 13 *tions 47117(b) and 47117(f)(2) of such title.*

14 ***(b) PROJECT GRANT AUTHORITY.***—Section 47104(c) of
 15 *title 49, United States Code, is amended, in the matter pre-*
 16 *ceding paragraph (1), by striking “March 31, 2016,” and*
 17 *inserting “July 15, 2016,”.*

18 ***SEC. 102. EXTENSION OF EXPIRING AUTHORITIES.***

19 *(a) Section 47107(r)(3) of title 49, United States Code,*
 20 *is amended by striking “April 1, 2016” and inserting “July*
 21 *16, 2016”.*

22 *(b) Section 47115(j) of title 49, United States Code,*
 23 *is amended by striking “March 31, 2016” and inserting*
 24 *“July 15, 2016”.*

1 (c) Section 47124(b)(3)(E) of title 49, United States
 2 Code, is amended by striking “\$5,175,000 for the period be-
 3 ginning on October 1, 2015, and ending on March 31,
 4 2016,” and inserting “\$8,193,750 for the period beginning
 5 on October 1, 2015, and ending on July 15, 2016,”.

 14 ed by striking “March 31, 2016” and inserting “July 15,
 15 2016”.

16 (g) Section 411(h) of the FAA Modernization and Re-
 17 form Act of 2012 (49 U.S.C. 42301 prec. note) is amended
 18 by striking “March 31, 2016” and inserting “July 15,
 19 2016”.

20 (h) Section 822(k) of the FAA Modernization and Re-
 21 form Act of 2012 (49 U.S.C. 47141 note) is amended by
 22 striking “March 31, 2016” and inserting “July 15, 2016”.

1 **SEC. 103. FEDERAL AVIATION ADMINISTRATION OPER-**
 2 **ATIONS.**

3 *Section 106(k) of title 49, United States Code, is*
 4 *amended—*

5 *(1) in paragraph (1), by amending subpara-*
 6 *graph (E) to read as follows:*

7 *“(E) \$7,711,387,500 for the period begin-*
 8 *ning on October 1, 2015, and ending on July 15,*
 9 *2016.”; and*

10 *(2) in paragraph (3) by striking “March 31,*
 11 *2016” and inserting “July 15, 2016”.*

12 **SEC. 104. AIR NAVIGATION FACILITIES AND EQUIPMENT.**

13 *Section 48101(a)(5) of title 49, United States Code,*
 14 *is amended to read as follows:*

15 *“(5) \$2,058,333,333 for the period beginning on*
 16 *October 1, 2015, and ending on July 15, 2016.”.*

17 **SEC. 105. RESEARCH, ENGINEERING, AND DEVELOPMENT.**

18 *Section 48102(a)(9) of title 49, United States Code,*
 19 *is amended to read as follows:*

20 *“(9) \$124,093,750 for the period beginning on*
 21 *October 1, 2015, and ending on July 15, 2016.”.*

22 **SEC. 106. COMPLIANCE WITH AVIATION FUNDING REQUIRE-**
 23 **MENT.**

24 *The budget authority authorized in this Act, including*
 25 *the amendments made by this Act, shall be deemed to satisfy*
 26 *the requirements of subsections (a)(1)(B) and (a)(2) of sec-*

tion 48114 of title 49, United States Code, for the period beginning on October 1, 2015, and ending on July 15, 2016.

SEC. 107. ESSENTIAL AIR SERVICE.

Section 41742(a)(2) of title 49, United States Code, is amended by striking “\$77,500,000 for the period beginning on October 1, 2015, and ending on March 31, 2016,” and inserting “\$122,708,333 for the period beginning on October 1, 2015, and ending on July 15, 2016,”.

TITLE II—REVENUE PROVISIONS

SEC. 201. EXPENDITURE AUTHORITY FROM AIRPORT AND AIRWAY TRUST FUND.

(a) *IN GENERAL.*—Section 9502(d)(1) of the Internal Revenue Code of 1986 is amended—

(1) in the matter preceding subparagraph (A), by striking “April 1, 2016” and inserting “July 16, 2016”; and

(2) in subparagraph (A), by striking the semicolon at the end and inserting “or the Airport and Airway Extension Act of 2016;”.

(b) *CONFORMING AMENDMENT.*—Section 9502(e)(2) of such Code is amended by striking “April 1, 2016” and inserting “July 16, 2016”.

1 **SEC. 202. EXTENSION OF TAXES FUNDING AIRPORT AND**
 2 **AIRWAY TRUST FUND.**

3 (a) *FUEL TAXES.*—Section 4081(d)(2)(B) of the Inter-
 4 nal Revenue Code of 1986 is amended by striking “March
 5 31, 2016” and inserting “July 15, 2016”.

6 (b) *TICKET TAXES.*—

7 (1) *PERSONS.*—Section 4261(k)(1)(A)(ii) of such
 8 Code is amended by striking “March 31, 2016” and
 9 inserting “July 15, 2016”.

10 (2) *PROPERTY.*—Section 4271(d)(1)(A)(ii) of
 11 such Code is amended by striking “March 31, 2016”
 12 and inserting “July 15, 2016”.

13 (c) *FRACTIONAL OWNERSHIP PROGRAMS.*—

14 (1) *TREATMENT AS NON-COMMERCIAL AVIA-*
 15 *TION.*—Section 4083(b) of such Code is amended by
 16 striking “April 1, 2016” and inserting “July 16,
 17 2016”.

18 (2) *EXEMPTION FROM TICKET TAXES.*—Section
 19 4261(j) of such Code is amended by striking “March
 20 31, 2016” and inserting “July 15, 2016”.
